**Title:** Shop Practicum II

**Catalog Description:**

This course provides supervised work experience at a sponsoring dealership which applies directly to previous automotive courses. Proof of employment and approval of faculty supervisor is required. If students plan to transfer to Weber State University, they must enroll concurrently in Weber State University AUTOSV 2860. This may incur additional costs.

**Justification:**

This course allows students to complete their training in automotive technology by obtaining actual work experience in the field. It is modeled after Weber State University's AUTOSV 2860.

**Student Learning Outcomes:**

Upon successful completion of this course, students will have the experience needed to be better able to perform in their field of work or study.

**Content:**

This course provides on the job work experience in the student's major.

Students are required to communicate about repair and maintenance issues to customers. Strategies for customer communications are emphasized, with feedback being provided for improvement.

Students participate in a shop practicum experience where workplace ethics are a key component of the evaluation process. Students learn the importance of punctuality, honesty, and hard work.
