# **Provided Services**

Aside from being in your corner, fighting for YOU, a Victim Advocate can assist with many things including:

- Crime Victims Reparations application
- Mental Healthcare
- Assistance with reporting to Law Enforcement or Title IX
- Accompaniment to interviews with Law Enforcement or Title IX if those options are pursued
- Support through a sexual assault forensic exam
- Safety planning
- A safe place to study, vent, or just sit and breathe.

## Court Relief Orders

Snow College Victim Advocate can assist in filing protective orders & stalking injunctions. Each have a specific list of qualifications in order to file. There is not a cost to file either petition. The Victim Advocate is not a lawyer & cannot provide legal advice or legal assistance. However, the Victim Advocate is available to discuss each situations & qualifications to apply. You do not have to hire a lawyer but you may if you so desire.

## Domestic Violence & JRA's

When an officer responds to a call of DV & has good reason to believe a crime has been committed, the officer SHALL make an arrest if:

- Suspect may continue to hurt the victim
- Recently cause serious injury to the victim
- Used a weapon
- Violated a Protective Order

Police will try to notify the victim if/when the suspect is released from jail. A suspect may not be released from jail unless ordered by the court or upon signing a Jail Release Agreement (JRA).

- Have no contact with the victim
- Not Threaten or harass the victim
- Not enter the victim's residence or other place occupied by the victim.

# **Victim Rights**

- Right to fairness, dignity, respect, privacy & due process
- Right to be free from harassment & abuse
- Right to timely notice
- Right to be informed of, present & heard, at important criminal justice hearings
- Right to reasonable protection
- Right to restitution
- Right to information & referral
- Right to apply for victim compensation
- Right to proceedings w/out unreasonable delay
- Right to confer
- Right to a copy of pre-sentence report & transcripts
- Right to reasonable intercession with professors, landlords & employers if necessary
- Right to report to Utah Crimes Victims Rights Counsel when Rights are Violated

# Crime Victim Reparations

#### WHO QUALIFIES?

- Victims who suffer physical or psychological injury or death as a direct result of a crime
- Family & dependents of deceased victims
- Utah Residents who have been victims in or out of Utah. Non-Utah Residents who are the Victim of a crime that took place in the State of Utah
- Crime is reported to Law Enforcement

   conviction is not required but enough
   information is needed from Law enforcement
   to substantiate a crime occurred

### WHAT MAY BE PAID?

- Medical care
- Dental care
- Mental Health counseling
- Relocation & related costs
- Loss of earnings
- Loss of support to dependents
- Child care
- Replacement of door locks, window or other essential personal property required for the health & safety of the victim
- Eyeglasses, hearing aids or other medically necessary devices
